Board Goals

The 2022 Board goals include items relative to mental health of the Athletic Administrator and studentathlete, supporting the new DEI committee's initiatives, promoting the new tax incentive for Athletic Administrators and coaches, promoting additional pay for Athletic Administrators that are CAA or CMAA certified, and provide virtual options for professional development.
