I am a former multi-sport high school student-athlete and high school varsity softball and volleyball coach. I am also the Treasurer and Membership Chair of the NHADA. I am truly humbled and honored to have been selected by the leadership of New Hampshire and Section 1 to serve as your representative for the next three years. I would also like to thank Jim Davis for his service to Section 1 the past three years.

I have known for several years that Section 1 is a model for other NIAAA sections and this year's membership commendations once again are an example of that. Well done to all eight states. Let's continue to recruit new members within our states. Section 1 achieved the best percentage of members possible with 99%.

- All states in Section 1 attained at least 70% membership commendation (Section with most states and highest percentage of states).
- All states in Section 1 are dual states.
- 100% States: Connecticut (129%), New Hampshire (134%), Rhode Island (158%)
- Increased membership by at least 10%: New York, Rhode Island
- Record membership: New Hampshire, New York, Rhode Island
